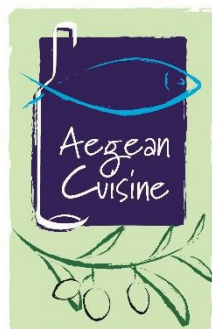

## CONDITIONS FOR THE INCLUSION OF CYCLADIC PRODUCTS IN THE AEGEAN CUISINE NETWORK

In order for a Cycladic product to join the Aegean Cuisine network, it must meet the following basic requirements:

1. The product should be **standardized**.
2. The **production/standardization unit** of the product should be located in the **Prefecture of Cyclades**.
3. The law should be in force **License to operate the production unit**. 4. Should be used **raw materials from the Cyclades or from the rest of the Aegean islands**, in measure of what is possible.
5. Products should be produced on the basis of **traditional recipes of the Cyclades** or with **innovative recipes as long as they use local raw materials**.

### PDO/PGI PRODUCTS

Products that are classified as PDO (Protected Designation of Origin) or PGI (Protected Geographical Indication) **are automatically and** automatically included in the Aegean Cuisine network.

### ADDITIONAL CLARIFICATIONS

#### NUMBER OF PRODUCTS TO BE INCLUDED

Each company has the opportunity to apply for inclusion in the network for those of its production products it considers to have the corresponding specifications.

Products that have been included in one of the previous cycles do not need to be reshipped, **unless their composition has changed**.

#### SPECIAL MARK AEGEAN CUISINE



Inclusion in the Network and the special mark will only concern those of each producer's products that are positively evaluated by the competent committee and the use and placement of the special mark on products that have not been approved will not be allowed. In case the use of the trademark is detected in non-evaluated products of the same producer, all its products are deleted from the Register of Cycladic products.

## The

trademark will be valid for as long as the composition of the product does not change. The producer is obliged to immediately inform the Chamber of Cyclades in case of changes in the composition of the product.

## PROCEDURE

In case you are interested in applying for the inclusion of products in the Aegean Cuisine network, you should follow the following procedure, which also applies to PDO/PGI products:

- Complete the online application**
- Post a copy of the current operating license of the production unit**
- Post copies of any quality assurance certifications (e.g. HACCP)**
- Please send us two (2) samples in the smallest commercially available package for each product**

The products must be shipped by post or courier to the following address **no later than Friday, May 22, 2026:**
